<u>Dwelling unit complete:</u> Service, security*, fire alarm, communications are included if performed by same installer. <i>Power Co. work order # required.</i>	\$175.00
<u>Additions, renovations including garages etc:</u>	\$75.00
<u>Temporary Service:</u> <i>Power Co. work order # required.</i>	\$40.00
<u>Permanent Service:</u> <i>Power Co. work order # required.</i>	\$45.00
<u>Security* / fire alarm, or combination:</u>	\$55.00
<u>Power limited:</u> Communication, or other low voltage wiring:	\$55.00
<u>Swimming Pool:</u>	\$75.00
<u>Solar P/V systems:</u>	\$125.00
<u>Single inspection Fee:</u>	\$40.00
<u>Emergency Inspection</u>	\$150.00

COMMERCIAL INSTALLATIONS:

<u>Temporary / Permanent Service:</u>	\$100.00
<u>New building, addition, or renovation:</u> Up to \$100,000 in building value.	\$200.00
For each additional \$20,000 in <u>building</u> value, or fraction thereof: <i>Fee includes fire, security* and communications if performed by same installer.</i>	\$45.00
<u>Building Shell Only:</u>	
10,000 sq. ft. or less	\$175.00
10,001 - 20,000 sq. ft.	\$200.00
20,001 - 50,000 sq. ft.	\$250.00
Over 50,001 sq. ft.	\$400.00
<u>Solar P/V systems:</u>	\$350.00
<u>Fire Alarm, Security*, Power limited, Communications:</u>	\$125.00
<u>Yearly Maintenance Permit:</u>	\$550.00
<u>Carnivals:</u>	\$75.00
<u>Swimming Pool:</u>	\$175.00
<u>Single Inspection Fee:</u>	\$100.00
<u>Emergency Inspection</u>	\$350.00
