### HYBRID PARTICIPATION IN-PERSON OR VIA ZOOM WEBINAR

Pursuant to MA Senate Bill 2457 signed by Governor Baker on June 16, 2021, a second bill (H4345) signed by Governor Baker on February 12, 2022 and a third bill signed on July 16, 2022 which allow government bodies to continue to conduct meetings virtually until March 31, 2023, as long as members of the public can easily access the proceedings in real time and participate remotely, this meeting will be conducted both in person and via remote participation.
