SELECT BOARD OPEN DISCUSSION

Mr. Helm said that the Board should receive all information in advance of the meeting regarding Public Hearings, to make an informed decision. Mr. Helm stated that the Board should require all requestors for public hearings to be in attendance. Mr. Bletzer agreed with Mr. Helm. Mr. Brindisi stated that he will relay that information to all Staff, to make sure that requestors are notified, and are in attendance for licenses, permits, and public hearings.

Mr. Bletzer requested that the Town Manager research potential options for sidewalk cleaners, Mr. Bletzer stated that he has noticed that the sidewalks on the waterfront are dirty. Mr. Brindisi stated that the DPW has researched a sidewalk cleaning machine with a power washer nozzle (for graffiti), Mr. Brindisi stated that the machine is approximately \$110,000. Mr. Bletzer requested that if available, ARPA funds should be used.

On a motion by Kevin Canty and seconded by Charlie Bletzer, the Board voted to reconsider the motion to approve the Administrative Notes and Licenses as a group.

Mr. Bletzer stated that he is concerned with Administrative Note 2, to authorize 2023 Summer Outdoor Dining for Anejo Plymouth Inc. d/b/a Anejo, 51 Main Street. Mr. Bletzer stated that Anejo already has designated patio outdoor seating in front of their building. Mr. Bletzer stated that he doesn't believe the sidewalk is wide enough to allow for seating along the sidewalk. The owner of Anejo withdrew his request.

Mr. Bletzer noted that enforcement needs to occur regarding unauthorized outdoor dining on sidewalks. Mr. Brindisi noted that some restaurants are utilizing tables and chairs for various usages on sidewalks. Mr. Helm stated that the Board should examine the definition of outdoor dining, now that the COVID-19 State of Emergency has expired.
