COMPLETE YOUR ANNUAL CENSUS FORM TO MAINTAIN YOUR ACTIVE VOTER STATUS

INACTIVE VOTERS

Registered voters who do not respond to the annual street listing by June 1st are considered inactive. Inactive voters are required to complete additional forms & show an ID at elections in order to vote. Voters **MUST** return a census form to avoid completing these forms at future elections.

WHY AM I RECEIVING MULTIPLE CENSUS FORMS?

Our office does our best to list all family members on a single census form, however, mistakes can occur due to different last names, members moving or failure to respond to the census annually. To correct this for next year, simply send back all the forms together with a note indicating you should all be together in one household OR write all missing names on a single form.

DELETING VOTERS

Inactive voters who **DO NOT** respond to the census or subsequent confirmation mailing and **DO NOT** vote for two consecutive biennial state elections will be deleted from the voting list.

To vote by mail you **must complete a new vote by mail application each calendar year**
