The campaign finance law, M.G.L. c. 55, requires you to file a pre-election campaign disclosure report (Form CPF M102), a copy of which is enclosed. This report must be filed with this office on or before May 13, 2022. The report must be received by this office no later than noon on that day.


Your report must disclose all campaign activity (all monies and in-kind contributions received, expenses paid and liabilities incurred) from the day following the ending date of the last report filed by you through May 3, 2022.

Please ensure that your report is complete before filing. Reports which do not conform to law cannot be accepted by this office and must be returned to you for correction. Your report must include the candidate's original signature in ink and must be received by this office no later than noon on May 13, 2022. By law, a postmark is not acceptable.

**IMPORTANT:** A new provision in the campaign finance law mandates that a **CIVIL PENALTY OF \$25.00 PER DAY UP TO \$1,000** be assessed personally against the candidate for any report which is filed after the due date and upon referral to the Office of Campaign and Political Finance. In addition, failure to file the report as required will subject you to referral to the Attorney General.
