The original filing of the above-referenced campaign finance report is being amended for the following reason(s):

The original report was accurate as to the total contributions actually received during the reporting period, however, an unforeseen technological issue prevented the Committee from accessing our account with Act Blue, our online donation vendor, and viewing the specific donor information for online contributions before we had to file the original report. That technological issue has since been resolved and we are filing this Amended Report in order to fully comply with the campaign finance laws and provide further transparency as to the donations received.


The Committee received five checks from Act Blue comprised of one or more of those online donations each, minus Act Blue's service fee. The original report accurately listed the amounts of each of those checks from Act Blue, but this Amended Report contains the donor information for the funds that those checks consisted of. Act Blue received \$763.78 in online donations towards the campaign minus a total combined service fee of \$30.19, leading to \$733.59 in funds actually received by the Committee from online donations.


The Receipts schedule of this Amended Report lists all online contributions separately by name of the donor, instead of listing them as coming from Act Blue, along with all the other donations received through other means. Online donors have (via Act Blue) after their name to signify that that specific donation was made online and that they are newly added to the Amended Report. These online donations record the amount actually donated before the service fee is taken out.

The Expenditures schedule has the total combined service fee of \$30.19 added to Line 10 as an un-itemized expense.

All other Receipts and Expenditures are unchanged from the original report. The In-Kind Contributions and Liabilities schedules are also unchanged from what was reported in the original report.
