If I qualify for this program, I understand that I may earn a maximum of \$1,500, which will be issued in the form of an exemption on my property tax bill. Persons who participate in the program will be advised that all earnings are "paid" exclusively in the form of an abatement (credit) to the tax bill. If a volunteer sells the property on which the tax is to be abated due to the performance of work-off services, it is up to the "seller" to ensure the reduction is considered at the time of closing for the benefit to be credited to the seller in the same manner as exemptions they are eligible for in that year.

I also understand that credits earned are not subject to Massachusetts state taxes but are subject to Medicare and Social Security and may be subject to Federal Income Tax. The total credit of the exemption would equate to the amount earned less Federal taxes, Medicare, and Social Security.
