CONNECTING GOVERNMENT & THE COMMUNITY

The Plymouth Select Board has recently been on the road, holding sessions in neighborhoods across South Plymouth, Cedarville, and Manomet to bring local government closer to the people it serves. Hundreds of residents have attended, filling community spaces to share their concerns directly with board members.

This initiative aimed to strengthen transparency and accessibility, while giving residents an opportunity to engage in conversations about issues impacting their neighborhoods. The strong turnout demonstrated a clear interest in local government and a desire for meaningful dialogue between citizens and their elected officials.

These open Q&A sessions have produced tangible outcomes. At the upcoming fall Town Meeting, the board is proposing the establishment of a special fund to help address challenges related to the sale of land previously classified under Chapter 61 of Massachusetts General Laws, ensuring resources will be available to mitigate impacts of development.

In Cedarville, residents' concerns about the capped landfill led to a commitment for quarterly testing of nearby monitoring wells to safeguard environmental and public health. In addition, the board agreed to create a committee to review the town's earth removal bylaw, responding to longstanding community questions about its adequacy and enforcement. Together, these steps reflect a direct response to residents' input and the board's commitment to act on local priorities.

SELECT BOARD APPROVES ANNUAL GOALS & PRIORITIES FOR FY2026

This past August, the Select Board voted to approve 81 Annual Goals & Priorities for Fiscal Year 2026. These goals will guide the Town's efforts in economic development, infrastructure, environmental protection, workforce development, and government efficiency.

A few highlights include:

- Economic Development: Advancing a downtown economic development plan to ensure a vibrant business center.
- Infrastructure: Developing and implementing a long-term plan for Memorial Hall.
- Environmental Protection: Completing the \$17 million Town Brook Restoration Project.
- Workforce Development: Creating strategies to recruit and retain police officers.
- Government Efficiency: Exploring opportunities to place town-owned buildings on the National Register of Historic Places.

These priorities reflect the Town's commitment to growth, sustainability, and community well-being—while honoring Plymouth's history.

Annual Fall Town Meeting Prep

As we have entered the fall months, the Town Clerk's Office has been busy preparing for the Annual Fall Town Meeting on Saturday, October 18, 2025. Town Meeting is the legislative authority for the Town of Plymouth, where Representative Town Meeting Members vote to enact bylaws, approve budgets, and authorize town spending.

To prepare for Town Meeting, the Town Clerk's Office notifies each Representative Town Meeting Member of the meeting's date, time, and location. Following special legislation enacted in 2022, the Clerk's Office also tracks members attending remotely. Any member wishing to participate and vote virtually must request this accommodation at least one week in advance and ensure they are set up with the proper technology.



When Representative Town Meeting Members arrive, each is checked in as a voter and provided with an electronic voting device for use during the meeting. The results of each vote, including how members voted, are displayed immediately and later posted on the Town's website.

Once all business is concluded, Town Meeting is adjourned and dissolved. The Town Clerk is then responsible for compiling the official record of motions, amendments, and votes. These proceedings become part of Plymouth's permanent records, preserved for future reference. The Town Clerk also prepares documentation for the Attorney General, bond counsel, and other interested parties to ensure that Town Meeting actions are properly enacted and comply with all applicable state and federal laws.

Plymouth Community Health Survey Frequently Asked Questions (FAQ)

The Town of Plymouth recently launched a Community Health Survey this summer, and we have received a lot of positive feedback so far!

What is the Plymouth Community Health Survey?

The Plymouth Community Health Survey is an opportunity for people who live and/or work in Plymouth to share their feedback and perspectives on health/wellbeing in our community.

Why is the Town conducting a Community Health Survey?

The Community Health Survey is an important initial step of the first-ever Plymouth Community Health Assessment and Community Health Improvement Plan (CHA - CHIP). Through the Plymouth CHA - CHIP Project, the Town of Plymouth will be able to collect data and develop a roadmap for community health.

Who is leading the Community Health Survey?

The Plymouth Department of Health and Human Services (HHS) is leading the survey in partnership with Health Resources in Action (HRiA), a non-profit organization working to achieve Plymouth's CHA - CHIP Project goals. HRiA will conduct data collection/analysis.

Who is eligible to take the Plymouth Community Health Survey?

If you live and/or work in Plymouth, you are eligible to complete the survey and enter for a chance to win one of three raffle prizes: an iPad with an Owl, a \$150 Amazon Gift Card, or a \$100 Amazon Gift Card. This is a unique opportunity to share your voice and be part of this historic launch!

Is survey participation anonymous? How will my data be used if I participate?

Survey participation is completely voluntary and anonymous! Survey responses will not be linked to individual participants. The Town of Plymouth and HRiA will not sell any information collected from this survey. Data collected from the survey will only be used to gain a greater understanding of the issues impacting the health/wellbeing of residents and inform future planning and services in Plymouth.

PUBLIC HEALTH DIVISION

AVOID WEST NILE VIRUS (WNV)



WNV is most often transmitted to humans by the bite of an infected mosquito. The mosquitoes that carry this virus are common throughout Massachusetts and are found in urban and rural areas.

While WNV can infect people of all ages, people over the age of 50 are at higher risk for severe infection.



MOSQUITO-PROOF YOUR HOME

Drain Standing Water:

- Mosquitoes lay their eggs in standing water. Limit the number of places around your home for mosquitoes to breed by draining or discarding items that hold water.
- Check rain gutters and drains.
- Empty unused flowerpots and wading pools and change the water in birdbaths frequently.

Install or Repair Screens:

- Keep mosquitoes outside by having tightly fitting screens on all windows and doors.

PERSONAL & PET PROTECTION TIPS

Apply Insect Repellent when Outdoors:

- Use a repellent with an EPA-registered ingredient, such as DEET, permethrin, picaridin, or oil of lemon eucalyptus according to the instructions on the product label.

Be Aware of Peak Mosquito Hours:

- Dusk to dawn are peak biting times for many mosquitoes. Consider rescheduling outdoor activities that occur during evening or early morning in areas of high risk.

Clothing Can Help Reduce Mosquito Bites:

- Wearing long sleeves, long pants and socks when outdoors will help keep mosquitoes away from your skin.
- Animal owners can help reduce mosquito risks by eliminating standing water from containers like buckets, tires, and wading pools—especially after heavy rain. Horse owners should keep horses stalled at night and consult a veterinarian about approved repellents and vaccines for WNV and EEE. Suspected cases must be reported to the Department of Agricultural Resources (617-626-1795) and the Department of Public Health (617-983-6800).

FEATURED FUNDING: GRANT DOLLARS AT WORK

Plymouth's departments and divisions are actively pursuing state and federal grant opportunities to advance capital projects and launch new programs. Highlighted here are just a few examples of the millions in grant funding Town staff secures annually to benefit the community.

Mass Save Community First Partnership Program

The Climate & Sustainability Division of the Department of Energy & Environment recently received a three-year grant through the Mass Save Community First Partnership Program, to fund the hosting of a full-time energy advocate at Town Hall.

Mass Save offers this opportunity to participating municipalities and local organizations to fund a multitude of energy efficiency initiatives through community outreach campaigns and direct work with constituents. The Department of Energy & Environment ("DEE") will use its \$256,500 award (\$85,500 x three years) to establish a three-year, full-time energy advocate position within the department. The advocate—who is now employed by the Town and stationed in the DEE office—will focus on outreach and engagement with the program's targeted constituent populations, such as low-income energy customers, landlords of 5-20 unit buildings (to benefit renters), and moderate-income consumers (both property owners and renters).

Initial outreach efforts will be primarily focused on a mailing included with quarterly billing information, social media campaigns, information sessions at public meetings, and tabling events in collaboration with local environmental community groups. Subsequent to community outreach efforts, Plymouth's energy advocate will implement a one-on-one coaching program with constituents, to facilitate participation in Mass Save-sponsored programs, such as: home energy assessments, residential weatherization upgrades, home heating and cooling upgrades, and small business energy efficiency upgrades.

Federal Grant to Support a Preservation Assessment at Burial Hill

The Cemetery & Crematory Division of the Department of Public Works successfully secured a \$23,400 federal grant through the U.S. Department of the Interior's National Park Service, to fund a preservation project at Plymouth's historic Burial Hill.

Offered through the National Park Service, the Historic Preservation Fund Grant Program is designed to commemorate the 250th anniversary of the founding of the nation by restoring and preserving sites and structures listed on the National Register of Historic Places.

Plymouth's award will cover 90% of the cost to produce a professional preservation assessment of approximately 1,000 headstones, grave markers, and obelisks at Burial Hill, on which the next phase of physical preservation work will be based.

UTILITY LOCATOR AND TRANSMITTER

The Town of Plymouth's insurance company, Massachusetts Interlocal Insurance Association (MIIA), offers a Risk Management Grant to its members. The Risk Management Grant is a yearly competitive grant program focusing on high-priority areas of program-wide risk, such as facilities management, employee health & safety, and cybersecurity. With funding from this grant, the Town has acquired a utility locator and transmitter for the Engineering Department.

The Risk Management Grant has been a tremendous benefit to Plymouth's risk management efforts. With this support, we've been able to invest in tools and equipment that prevent accidents and strengthen procedures that protect both employees and residents. Such tools that have recently been acquired through this grant are a utility locator and transmitter.

A utility locator is a device used to detect and locate underground utility lines. Utilities are essential for the health, safety, and economic development of our town by providing critical services like water, electricity, and sanitation. Without reliable, affordable, and well-maintained utility infrastructure, a town cannot function properly, attract businesses, or ensure a good quality of life for its residents.

Utility locators are essential for preventing damage to underground utilities during excavation activities. Without accurate information about the location of the underground utilities, excavation work can present significant safety risks including electrical, gas, and other trenching hazards. By using utility locators to accurately locate and mark the location of underground utilities these hazards can be avoided and ensure excavation work is conducted safely and efficiently.

These improvements reduce risks, lower potential costs, and help safeguard our community's resources. Most importantly, the grant has given us the ability to take a proactive approach—focusing on prevention rather than reaction—so that we can continue building a safe and resilient work environment.

PLYMOUTH AGGREGATION RATE

The Town of Plymouth has signed a forty-eight month contract with a new electricity supplier, First Point Power. Beginning with the October 2025 meter reads, the Plymouth Community Choice Power Supply Program will have a new rate of \$0.13552 per kWh for a 100% green product, which is derived from National Wind Renewable Energy Certificates (RECs).

For Plymouth residents and businesses who are enrolled in the Town's Program, the current rate of \$0.13940 per kWh, which is in effect for the September meter reads, will expire with the October 2025 meter reads and the new rate of \$0.13552 per kWh will take effect. This represents a decrease of \$2 per month on the supply side of the bill given average usage of 600 kWh. For comparison, the rate for the June - August meter reads was \$0.14733 per kWh, so the new rate is about \$7 per month lower than that summer rate. In addition, this new rate is 9% lower than Eversource's Residential Basic Service rate of \$0.14884 per kWh. Residents can expect to see an average savings of \$8 per month for the months of October 2025 through January 2026.

Plymouth launched its electricity program in October 2017 in an effort to develop an energy program that would be stable and affordable. From inception through March 2025, the Program has saved residents and small businesses over \$46.6 million in electricity costs as compared to Eversource Basic Service. It is important to note that no action is required by current participants. This change will be seen on the November 2025 bills. All accounts currently enrolled in the Program will see the new rate and First Point Power printed under the "Supplier Services" section of their monthly bill.

The Plymouth Community Choice Power Supply Program has no fees or charges. However, anyone switching from a contract with a third-party supplier may be subject to penalties or early termination fees charged by that supplier. Ratepayers should verify terms before switching. Basic Service rates change twice a year or more, depending on rate class. As a result, the aggregation rate may not always be lower than the Basic Service rate. The goal of the aggregation is to deliver savings over the life of the program against Eversource Basic Service. However, future savings cannot be guaranteed.

Eversource customers who meet certain means criteria can qualify to receive a discount on their electric bills. COASTAL MEASURES

This August, our Department of Energy and Environment (DEE) team hit the water with Coastal Measures and Atlantic Resiliency Innovation Institute (ARII) to deploy a sensor buoy off the coast of Plymouth. It's part of a growing network stretching from the North Shore to Cape Cod – built to help communities prepare for stronger storms.

This buoy is now tracking real-time conditions like:

- Wave Height & Direction
- Water Temperature
- Barometric Pressure
- Wind Speed & Direction



We first connected with Coastal Measures and ARII at last year's Blue Future Conference in Plymouth – a perfect example of how meaningful conversations can lead to tangible collaborations at sea. The data collected from this network will directly support Plymouth's Climate Action and Adaptation Plan by informing local resilience and preparedness efforts. HOLIDAY CYBERSECURITY TIPS

It's that time of year again when the holidays are fast approaching, and for many, this can be a hectic time of year – buying gifts online, making travel arrangements, and wanting to give back to charitable organizations. It's also a busy time for cybercriminals who are trying to take advantage of you. But, you can fight back against cyberthieves and better protect your personal information by following the tips below:

Online Shopping

When shopping online, several tips will help you avoid falling victim to an online scam:

- **Keep a Clean Machine:** Ensure your devices are free from malware and infections by using the latest versions of software and apps. Be sure to update the software on your computer and phones (for convenience, set your devices to automatically update software).
- **Use Secure Wi-Fi:** Avoid public Wi-Fi for shopping - use a VPN or your phone's hotspot instead.
- **Lock Down Your Login:** Use strong, unique passwords and enable multifactor authentication (MFA) when available.
- **Resist the Urge:** Avoid deals that seem too good to be true and buy only from trusted retailers.
- **Think Before You Click:** Be wary of emails from unknown senders and avoid clicking on suspicious links.
- **Shop Securely:** Check to make sure you're shopping on a site that uses SSL protection. Look for "https" in the URL to ensure the site is secure.
- **Pay Wisely:** Use credit cards or reliable payment services like Google Pay, ApplePay, or PayPal.
- **Monitor Your Accounts:** Regularly check your financial accounts for any suspicious activity.
- **Don't Provide Information:** Common scams include asking you to verify your delivery address or confirm your purchase or account.

Giving Online

Cybercriminals know the holidays spark the desire to give back, making charity donations a hot target.

- **Do Your Research First:** Never feel pressured to give on the spot. Use resources such as Charity_Navigator, CharityWatch, or GiveWell, to verify organizations before donating.
- **Ignore Unsolicited Requests:** Be cautious of emails and calls asking for donations. Donate directly through official websites.
- **Think Before You Pay:** Never wire money or send cash; use secure payment methods.
- **Double-Check the Website:** Cybercriminals often create websites and names that are very similar to legitimate, reputable organizations. Check the spelling of the organization's name and make sure the URL is correct.

While Traveling

No one is exempt from the threat of cybercrime, whether at home or on the go, but you can follow these simple tips to stay safe online when traveling during the holidays:

- **Avoid Free Wi-Fi:** Use a VPN or your mobile hotspot instead of public Wi-Fi.
- **Confirm Your Network:** If you do connect to public Wi-Fi, verify the network name and login procedures with staff before connecting.
- **Disable Auto-Connect:** Manually connect to networks and Bluetooth devices only when you want to.
- **Secure Your Devices:** Keep track of your laptop, smartphone, tablet, and accessories while in public places.
- **Avoid Shared Computers:** Don't make purchases or log into email on publicly shared computers. You don't know if the systems are up to date with the latest security software or if the machines are safe.

BUILDING LEADERS: PLYMOUTH POLICE YOUTH ACADEMY



This summer, a group of local students stepped into uniforms, lined up in formation, and began an unforgettable two-week journey at the Plymouth Police Youth Academy.

The program, led by School Resource Officers and made possible through the strong support of Chief Flynn and Deputy Chief LeBretton, is offered completely free of charge. Each cadet earns their spot through an application process, and from day one, they're challenged to grow in confidence, discipline, and teamwork.

Mornings begin with rigorous drill and ceremony, teaching cadets the value of discipline and precision.

Team-building exercises quickly turn strangers into teammates, while workshops with the motivational speaking group People of Action inspire cadets to push past their limits and believe in themselves.

Throughout the academy, cadets learn directly from Plymouth Police Officers and professionals across multiple agencies. From defensive tactics and the clinician co-response team to lessons in communication and investigative work, every day offers something new.

Some of the most memorable experiences include visiting the Plymouth County Sheriff's Department for K9 demonstrations, crime scene simulations, and communications training. At Plymouth District Court, cadets observe arraignments and track a case through the judicial process, gaining a behind-the-scenes look at how the system works.

Additional classes and demonstrations are led by the Plymouth County District Attorney's Office, the Massachusetts State Police Air Wing, Boston MedFlight, and the Plymouth Harbor Master to further broaden cadets' perspectives.

Training at the Plymouth MPTC facility adds to the realism. Marching in the same halls as real recruits, cadets get a taste of what it means to prepare for a career in law enforcement. And thanks to support from Plymouth Public Schools, they not only have space to train, but also graduate CPR certified, a life skill they carry forward.

The academy concludes with a powerful graduation ceremony at Memorial Hall. As cadets march in before their families, friends, and the community, the pride in the room is undeniable.



By the end of the two weeks, the transformation is clear. Cadets leave with more than just knowledge of law enforcement—they leave with greater confidence, teamwork, and respect for themselves and others.

COMMUNITY WILDFIRE PROTECTION PLAN



THE PLAN

The Town of Plymouth Massachusetts has contracted SWCA Environmental Consultants to work in collaboration with regional land management agencies and non-profit organizations to develop the 2026 Town of Plymouth, MA Community Wildfire Protection Plan (CWPP). A CWPP is designed to assist local land managers and property owners in mitigating wildfire risk by assessing areas at risk and recommending measures to decrease those risks. You (the public) can play a part in crafting fire mitigation recommendations to reduce risk in your community. Read below to find out more about the collaborative Community Wildfire Protection Plan process and public involvement.



WHAT DOES A COMMUNITY WILDFIRE PROTECTION PLAN DO?

- Identify areas at risk for wildland fire
- Make recommendations for hazardous fuels treatments (vegetation thinning)
- Prioritize areas for wildfire mitigation funding
- Make recommendations for homeowners to reduce fire risk
- Ask the public to share ideas about wildfire prevention and identify community values at risk

COMMUNITY FACT

The 2026 Plymouth, MA CWPP marks a planning milestone as the first of its kind for the project area. This endeavor signifies a pivotal step towards safeguarding the region's communities and fostering resilience against the growing threat of wildfires.

WHY YOU SHOULD BE INVOLVED

This CWPP is designed to assist municipalities and landowners in promoting wildfire management strategies tailored to the northeast's unique communities and landscapes. It is important that this process is collaborative. GET TO KNOW



ASSISTANT DIRECTOR OF PUBLIC WORKS: JAMES DOWNEY

James Downey serves as the Assistant Director of Public Works (DPW) for the Town of Plymouth. In this role, he oversees key divisions and functions within the department, including Solid Waste and Recycling, Fleet Maintenance, Transportation Improvement Projects, and Roadway Preservation and Construction. He also leads public outreach efforts and plays an important role in labor relations, budgeting, and capital planning.

Mr. Downey earned his Bachelor's Degree in Civil Engineering from Northeastern University in 1998. He began his career in the private sector, where he worked for six years before transitioning to public service with the City of Boston. In 2006, he joined the Town of Plymouth as a Transportation Engineer in the Engineering Division. Over the years, he served as Acting Town Engineer before being promoted to Assistant Director in January 2024.

With nearly two decades of service to Plymouth, Mr. Downey has developed a strong passion for road reconstruction projects and addressing traffic-related challenges such as sidewalks, ADA compliance, speeding, signage, and traffic signals. One of the unique aspects he values about public service being able to meet and hear from residents, along with the opportunity to oversee roadway projects from start to finish—creating balanced streets designed for cars, bicycles, and pedestrians alike.

Mr. Downey has also played a key role in shaping and implementing the Town's Pavement Management and Annual Road Program, which oversees more than 300 miles of paved roads. His leadership has guided efforts in pavement evaluation, prioritization of treatments, reconstruction and maintenance planning, and budget management.

What Does the Future Hold?

The Department of Public Works (DPW) is currently working with two local developers to complete the intersection improvements at Long Pond Rd at Halfway Pond, and Clark Rd at Pinehills Dr.

The DPW is also continuing to work with MassDOT on the long-awaited State Road Corridor improvements in Cedarville, spanning from Hedge Pond Road to Herring Pond Road.

Looking ahead, Mr. Downey is eager to place a stronger focus on Solid Waste and Recycling initiatives, including projects such as the Swap Shop and Food Waste Composting.

OUR HISTORY

A Brief History of Memorial Hall

During the late 19th and early 20th centuries, the idea of constructing a Town auditorium was discussed regularly. Persistent disagreements, however, prevented any project from moving forward. Finally, in 1919, Town Meeting voted to appropriate \$300,000 for the construction of a memorial building to honor local veterans of the Spanish-American War and World War I.


The selected site was part of the former estate of Lydia Lothrop, which was recently purchased by the Town. At the time, the property held a house that would later be known as the Hedge House Museum. The Town sold the building to the Plymouth Antiquarian Society, which moved it to Water Street, where it remains today.

Discussion about the project continued for several years, with debate at multiple Town Meetings. In 1924, the cornerstone of the new building was laid, and by 1925 construction was complete. A dedication ceremony was held the following year, formally opening Plymouth Memorial Hall to the community.

For many years, the building served as a central gathering place. Town Meetings were held at Memorial Hall until 1964, and local high school graduations have occasionally been hosted there as well. Over time, its role shifted, but it has remained active as a civic center.



Today, Plymouth Memorial Hall continues to host public events, concerts, and community activities, while also serving as home to veterans' organizations and the Hall of Flags.


