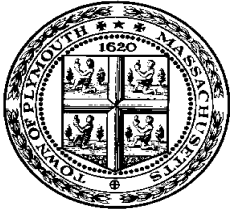

CANDIDATE AGREEMENT
Regarding Political Signs

I, _____, Candidate of _____ certify as follows:

1. I understand that the maximum size of a political signs is five (5) square feet.
2. I understand that political signs are allowed on private property only with the property owner's approval. Political signs shall not be mounted on trees, fences or telephone poles etc.. Any signs placed on Town or State property will be removed.
3. The Candidate CANNOT assume that his/her sign is allowed where other signs exist. Permission must be granted by the property owner.
4. I understand that political signs may be erected and maintained for a period of three (3) months and are non-renewable.
5. I understand all political signs must be removed within one week after the election.

I hereby agree to comply with the regulations set forth in the Town of Plymouth Zoning Bylaw section 205.19, conforming non-identification signs and will be responsible for the placement and removal of these signs. Any signs that do not conform to these regulations will be removed.
